What Happens at NMAC Meetings?

During NMAC meetings, participants learn about and discuss site issues and provide their individual input to the U.S. Environmental Protection Agency (EPA). Participants also hear presentations on site investigations and cleanup activities, review site documentation, ask questions, voice concerns and enter into a dialogue with other meeting participants. The NMAC provides a public forum that allows people in the community to actively participate in the cleanup decision-making process.

Individual meeting participants represent diverse community points of view. They bring issues and concerns related to the cleanup process to the attention of EPA and other interested parties.

Purpose of NMAC

The mission of the NMAC is to cooperate with EPA, other government agencies, and responsible parties to ensure a clean, healthful, and desirable environment for everyone who lives or works in close proximity to the four federal cleanup sites in Northeast Mountain View.

These four sites are the Middlefield-Ellis-Whisman (MEW) Study Area, the former GTE Government Systems site, the former Naval Air Station Moffett Field site, and the Jasco Chemical site.
